We have performed our due diligence and reviewed the raw materials used to formulate the items produced by Advanced Digital Cable, Inc; and found that they do not contain any of the compounds listed, or contain levels making them items of concern, in the complete RoHS Substance of Very High Concern (SVHC) listings as of Jan 3, 2025. These items are: Lead (Pb), Cadmium (Cd), Mercury (Hg), Hexavalent chromium (Hex-Cr), Polybrominated biphenyls (PBB), Polybrominated diphenyl ethers (PBDE), Bis(2-Ethylhexyl) phthalate (DEHP), Benzyl butyl phthalate (BBP), Dibutyl phthalate (DBP), and Diisobutyl phthalate (DIBP).
